ENCKEP: summary

- Brought together policy makers, clinicians and optimisation experts in Europe to:
 - exchange best practices and scientific state of the art with respect to national KEPs
 - ii. develop a jointly-used, common framework for data and optimisation
 - iii. develop and test a prototype for transnational KEPs
 - iv. stimulate European policy dialogue
- 28 participating countries and 5 international organisations
- Sep 2016 Mar 2021, Chair from May 2018 onwards
- Budget approx. €145k p.a.



Achievements of ENCKEP (cont)

- Meetings to enable knowledge exchange:
 - workshops (15), conferences (3), training schools (4)
- Knowledge exchange from further afield:
 - ANZKX, India, Saudi Arabia, UNOS
- Training opportunities for ECIs through STSMs and conference grants
- Work of the action has influenced the development of national and transnational KEPs
 - e.g., STEP (13 transplants conducted in 2020)
 - other national and transnational schemes

KEP-SOFT: Software for Transnational Kidney Exchange Programmes

- COST Innovators Grant IG15210
- A 1-year "follow-on" from CA15210
- Main aim: deliver KEP-SOFT
 - a flexible software product for conducting national and transnational KEPs, suitable for deployment by National Transplantation Organisations



Future plans

- Apply for Horizon Europe funding, e.g.,
 - Synergy grant
 - Specific calls
 - MCSA doctoral training network
