

# UK Participation in EU Programmes for Research, Innovation, Earth Observation and Higher Education

UKRO maintains this factsheet to provide the latest information on UK participation in EU funding schemes for research, innovation and earth observation. It provides an overview of the opportunities and signposts stakeholders – both UK organisations and our partners in Europe and beyond – to relevant official documentation.

## **UK association to Horizon Europe and Copernicus**

As of 1 January 2024, the UK has associated to the Horizon Europe and Copernicus programmes.

UK organisations are able to participate in Horizon Europe calls for proposals on the same terms as institutions from other Associated Countries, including leading consortia and receiving EU funding, from the 2024 Work Programme onwards.

Participation in <u>Copernicus</u>, the EU Earth Observation programme, allows the UK to access state-of-the-art services and products to monitor the Earth, as well as providing the UK research community with access to unique data, which is often required on Horizon Europe projects.

The UK Government has published a helpful <u>explainer document on UK association to Horizon</u>, which includes clarifications on many issues related to the UK association to both programmes.

# **Horizon Europe Work Programme 2025**

Work Programmes set out funding opportunities under Horizon Europe, and detail everything potential applicants need to know on the scheme in question, including objectives, priorities, funding available, and eligibility requirements; there are separate <a href="Work Programmes for the different funding">Work Programmes for the different funding instruments</a> within in Pillar 1, Pillar 2, Pillar 3 and Widening and Strengthening the European Research Area.

Throughout Horizon Europe, annual updates to Work Programmes reflect the changing priorities and needs of the EU and its member states. **The 2025 Work Programme** was pre-published on 28 April this year and formally adopted on 14 May 2025.

Every Horizon call for proposals has a call identification (ID) number, which sets out which programme year it belongs to. This number is set out clearly for each call in the Work Programme and on the EU's <u>Funding and Tenders Portal</u>. If the call ID includes '2025', the call will be part of the 2025 Work Programme.

The following table contains information about the opening dates and deadlines for calls within the 2025 Work Programme. These are provided in chronological order and are only intended to give applicants a general overview of 2025 deadlines. Applicants are encouraged to read the Work Programme carefully and check each call's opening date and deadline early on.

The final Work Programme of Horizon Europe will be published in 2026 and will cover both 2026 and 2027.

# Transitional arrangements for ongoing projects and applications made prior to Horizon Europe association

UK applicants to calls in 2021, 2022, and 2023 Work Programmes were fully eligible for evaluation by the EU and, if successful, to receive funding from the UK Government through the <a href="UK Horizon"><u>UK Horizon</u></a> **Europe Guarantee Scheme**.

During the period of non-association, UK applicants were not eligible to lead consortia or count towards the minimum number of countries required to meet eligibility rules for applications for transnational projects.

UK Research and Innovation (UKRI) has published <u>guidance</u> on UK participation in the 2021, 2022 and 2023 calls, together with <u>detailed instructions</u> on how to apply for the Guarantee funding.

#### Key points for applying to the UK Horizon Europe Guarantee Scheme

In order to be eligible for the UK Guarantee, UK applicants must continue to apply for funding from the EU as Beneficiaries and not as Associated Partners

UK participants who have received a UKRI grant under the Horizon Guarantee will remain on it for the lifetime of the project, subject to UKRI's bespoke terms and conditions.

### **UK participation in other EU programmes**

The UK will be considered a **non-associated third country** for all other EU programmes, including **Erasmus+** and Euratom. UK organisations may participate in calls for proposals under these programmes only if the relevant programme's legal basis allows for this. The relevant call documents will normally list the countries, which are eligible to participate in projects and to receive funding.

In most cases, organisations from third countries can participate in EU projects as Associated Partners without receiving EU funding, which means they need to cover their own costs. Furthermore, it is also normally possible for such organisations to participate as Third Parties such as Subcontractors, subject to the standard rules of the programme.

In line with the preferences of the UK fusion sector, the UK has decided to pursue a domestic fusion energy strategy instead of associating to the EU's **Euratom programme**. This will involve close international collaboration, including with European partners, and a new, cutting-edge alternative programme, backed by up to £650m to 2027.

# **UK Participation in COST Actions**

COST is an intergovernmental framework consisting of more than 40 countries. Although it is separate from the Horizon Europe programme, it is operationally funded by it.

As the UK is a <u>Full Member of COST</u>, UK-based researchers and innovators are fully eligible to apply to and participate in COST Actions, which fund **interdisciplinary research networks** that coalesce researchers and innovators together on topic for 4 years.

#### **Article 22.5 and Exclusions**

The UK Government's agreement with the EU means that UK researchers and businesses can participate in all areas of Horizon with very limited exceptions: the EIC Fund, which provides equity



finance support to EIC Accelerator projects, and a small part of the programme focused on some emerging technologies where the Commission has restricted participation since 2021. This has previously included calls from quantum and space, and for the 2025 Work Programme, AI, high performance computing (HPC) and telecommunications were also brought into scope for potential restrictions.

Following an assessment of UK eligibility, we have now received official confirmation from the European Commission that **UK researchers and businesses are eligible to apply to the vast majority of sensitive calls in the 2025 Work Programme**.

Some blanket restrictions still apply to all non-EU/EEA countries for a small number of Horizon Europe space technology projects focussed on In-Space Operations & Services and EEE components for EU non-dependence. These calls represent a very small proportion of the overall programme and no other non-EU/EEA countries currently have access to these calls. All other space calls are open to the UK including those focussed on access to European spaceports and space transportation systems, and those that help to further exploit Copernicus data.

# **Background information on association and the Withdrawal Agreement:**

- UK association came after formal adoption of an agreement on 4 December 2023 in the form
  of a protocol to the <u>Trade and Cooperation Agreement</u>, by the EU-UK Specialised
  Committee on Participation in EU Programmes.
- The European Commission and the UK Government published a **joint statement** on UK association to Horizon Europe and Copernicus as of 1 January 2024.
- While more and more calls will reach the end of their lifecycle and new calls will be covered by Association, the UK Government continues to provide guidance on <u>EU-funded programmes</u> under the Withdrawal Agreement and more specifically on <u>Horizon 2020</u> on its websites.
